## ***Midweek Triples League Rules***

### **1 League Management**

- 1.1 The entire control of the Midweek Triples League shall be vested in the Management Committee of the Portsmouth & District Bowling Association (P&D).
- 1.2 Entry to the League is open to all Clubs affiliated to the P&D.

### **2 Joining or Withdrawing from the League**

- 2.1 Applications to enter the League must be forwarded to the P&D Mid-Week League Secretary not later than the 31st October each season.
- 2.2 Applications to Withdraw a Side must be notified to the Mid-Week League Secretary at the conclusion of the current season.

### **3 League Composition**

- 3.1 The Midweek Triples League consists of:
  - 3.1.1 A Town Section, consisting of:
    - 3.1.1.1 A Blue Division
    - 3.1.1.2 A Red Division
  - 3.1.2 A District Section, consisting of:
    - 3.1.2.1 One (1) or More East Divisions
    - 3.1.2.2 One (1) or More West Divisions
- 3.2 For those Clubs who have entered more than 1 Side in the Midweek League, a player is NOT allowed to Play Skip in Different Sides.
  - 3.2.1 The **Penalty** for infringing this Rule is the deduction of 6(six) points from their total for that season.
- 3.3 Sides competing in the Divisions of the Town and District Leagues shall be determined by the Midweek Triples League Secretary each season.

### **4 Divisional Composition**

No Division shall consist of more than 10 Sides, playing one "Home" or "Away" afternoon match per week, throughout the Bowling Season.

### **5 League Fixtures**

- 5.1 Competing Clubs MUST nominate their Day (or Days) of the week, for the playing of Home Fixtures, which can either be Monday, Tuesday Wednesday or Thursday.
- 5.2 Any Club wishing to alter their Nominated Day(s) for the following Season **MUST** inform the Midweek League Secretary by 1<sup>st</sup> December of current season.
- 5.3 Fixtures will be arranged by the Midweek League Secretary.
- 5.4 The Start Time for a match shall be No Later than 2.00pm.
  - 5.4.1 **NOTE:** The Start Time may be brought forward by Mutual Consent.
- 5.5 Each Match will consist of 18 ends and, as per P & D League Rules, reciprocal Green Fee arrangements must be approved.

## **Midweek Triples League Rules**

### **6 Side Format**

6.1 A Side consists of 9 players who shall play as 3 Triples.

6.2 Every player must be a bona-fide member of the Club for whom he plays and be Registered to Play in P & D Competitions (i.e. Capitation Fee paid).

6.2.1 The **Penalty** for playing a Non-Registered Player is the deduction of 6(six) points from their total for that season.

### **7 Match Points**

Points are awarded as follows:

- 2 Points for each winning Triple;
- 6 Points to the Side having the Highest Aggregate Shots at the End of the Match;
- 1 Point each for Drawn Triples; 3 Points each for Tied Aggregate Shots.

### **8 Playing Rules**

8.1 All Games shall be played in accordance with the current Laws of the Sport of Bowls, adopted by World Bowls, the English variations (Bowls Laws).

8.1.1 **NOTE:** There are Local P&D Amendments to these Bowls Laws which are shown in the Rules that follow. (see Rule 9.5.2)

8.2 In the event of a Side arriving to play a MWT Match with less than 9 players, they shall forfeit 2 Rink Points, and have **5 shots** recorded against them.

8.3 It is not permissible for a MWT Match to be played with less than 6 players in any one Side.

8.4 ALL members of a Midweek Triples League Side must ensure that the Bowls they use and their Dress Code are in accordance with P&D League Rules 12 - Player Regulations.

#### **8.5 Player Substitution:**

8.5.1 If a player has to leave the green during the game due to illness or some other reasonable cause and they cannot return within 10 minutes, then, if both Skips agree, or, if not, both Side Captains agree, a Player Substitution can be made.

8.5.2 The Substitute **MUST** play in any position Other than Skip, and the other members of the rink can rearrange their positions as necessary (as per Bowls Law 33.4).

8.5.3 The name of the Substitute **MUST** be shown on both scorecards.

8.5.4 If an Eligible Substitute is not available, then their Opponents will be awarded either a **5-0 win**, or the score at the point the player left the game, whichever is greater.

8.5.5 **NOTE:** If it comes to the attention of the Midweek Secretary that this has been broken, then he will call a Council In Appeals meeting to adjudicate on the matter.

## **Midweek Triples League Rules**

### **8.6 Conceding Matches**

8.6.1 **If a Side Concedes a game to their opponent because they CANNOT field the minimum number of players permissible as set out in Rule 8.3, then the following Match Result will apply:**

**8.6.1.1 The Side who have received the Concession will be awarded:**

- **A 15 Shots to Zero Victory;**
- **8 Match Points.**

**8.6.1.2 The Side who have conceded the game will receive:**

- **A Deduction of 4 Match Points.**

8.6.2 **i.e. Match Points will be 8 for the "Winner"; Minus 4 for the "Loser".**

8.6.3 **NOTE: Either Side does have the Right Of Appeal to the Council In Appeals Committee.**

### **9 Match Postponements/Abandonments**

9.1 Once the season has started, games can only be postponed due to an Unfit Green or a National Club Competition.

9.1.1 If a Club wishes to postpone a game for any other reason they must first get the agreement of the Midweek League Secretary.

9.1.2 Only on his say so can the match then be postponed.

9.2 The Midweek League Secretary MUST be informed within 24hours when a match is Postponed or Abandoned.

9.3 Matches Abandoned due to weather conditions, nor played for any other reason on the original date, MUST be rearranged by mutual agreement and played before the Divisional Play Off Dates.

9.4 The Midweek League Secretary MUST be informed of the re-scheduled date within 14 days of the original date of the game.

9.4.1 The **Penalty** for not adhering to this is the deduction of 4 (Four) points from both Clubs.

#### **9.5 For Abandoned Matches:**

9.5.1 The Signed Scorecards for Unfinished matches MUST be forwarded to the Midweek Secretary, with copies kept for the continuation of the match.

9.5.2 When the match is restarted, then the remaining ends shall be played in accordance with the Bowls Laws with the following alternative:

9.5.2.1 A Maximum of 3 (three) Substitutes may be allowed, with no more than 2 in any one Triple.

9.5.2.2 A Substitute is NOT allowed to Skip (as per Bowls Law 33.4).

9.5.2.3 Should a Club break this Rule, then their Opposing Side will be awarded the Triple win, with a match score of either that as it was when the match was abandoned or a 10-0 win, whichever is greater (as per Bowls Laws 32.4.2 & 33.8).

### **10 Adverse Weather**

10.1 In the event of Bad or Poor Weather, the Home club should check their green and/or weather forecast by Noon on the Match Day and make a decision on playing or not as the case may be and to then inform their opposing Side Captain if the game is to be postponed.

- 10.2 This deadline is to give both captains sufficient time to inform their players that the match has been postponed, thereby preventing unnecessary travel.
- 10.3 The Council in Appeals shall be the governing body to Award/Deduct points for any Unfulfilled Fixture(s) and/or take any further appropriate action.

### **11 Match Results**

- 11.1 The HOME Side MUST inform the Midweek League Secretary of the Match Result by 10am of the day following the completion of the game.
- 11.1.1 The **Penalty** for failing to meet this deadline is the deduction of 4 (Four) points from the Home Side.
- 11.2 Each Club is responsible for ensuring that the signed SCORE CARDS from the game be RECEIVED by the Midweek League Secretary within 4 (Four) working days of the completion of the match.
- **NOTE:** Electronic Copies of the signed score cards are acceptable.
- 11.2.1 The **Penalty** for failing to meet this deadline is the deduction of 4 (Four) points from the relevant Side.

### **12 Score Card Responsibilities**

- 12.1 After the rinks have been drawn and side names have been entered, both Side Captains MUST ensure that the names on all the cards are the same on BOTH sets of cards before the games commences, as per Bowls Law 40.1.7.1.
- 12.1.1 The **Penalty** for failing to do so is the deduction of 4 (Four) Points from both Sides.
- 12.2 The Skip of each Rink is responsible for keeping the score.
- **NOTE:** This CANNOT Be Delegated.
- 12.3 During the game, they MUST ensure their card and the opponents match.
- 12.4 At the end of their match, each Skip MUST ensure that both cards show the same result and then sign both cards, thereby showing they have performed this check. They MUST also record the time the game finished on their card. (As per Bowls Law 40.1.7.5).
- 12.5 Finally, once ALL Score Cards have been completed and signed, it is the responsibility of each Side Captain to ensure that they agree the Results of the match in terms of Rink Scores, Total Score and Match Points.
- 12.5.1 The **Penalty** for failing to do so is the deduction of 1 (One) Point for each Incorrect Scorecard from both Sides.

### **13 League Position**

- 13.1 In the event of two or more sides completing their Season with the same number of Points, the side gaining more Rink Points will be adjudged to have the better League Record.
- 13.2 If this fails to determine the League Positions, Shot Difference will decide.

## ***Midweek Triples League Rules***

### **14 Section Champions**

- 14.1 The Winner and Runner-Up of the Town and District Sections will be determined by a Two-Legged Final, as follows:
- 14.1.1 In the Town Section, the Winner of the Blue Division will play the Red Division.
  - 14.1.2 In the District Section, it is the Winner of the East and West 1st Divisions.
  - 14.1.3 Which Side plays at Home in the 1st Leg will alternate each year.
- 14.2 These deciding Two Leg Matches will be arranged by the Midweek League Secretary and played in the week following the completion of All Matches in the relevant Section
- 14.3 Both Legs will be played in "Whites".
- 14.4 The Aggregate Shots Gained over the two leg matches shall decide the winners, and the second Match in Both Sections.
- 14.5 Prior to the commencement of the Second Leg Match, the Home Captain shall Nominate the Rink who will play the Extra End or Ends, until a result is achieved in the event of a Tied Match over the two legs (e.g. Rink 3 will play Extra ends).
- 14.5.1 This will be a Rink Number and NOT a Nominated Skip.
  - 14.5.2 This MUST be Agreed BEFORE the Cards are Matched.

### **15 Trophies**

The Winner and Runner Up of each Section, together with the Winners of the Lower Divisions in the District Section, will receive a Commemorative Plaque to keep.
